## ART. 2 DESCRIPTION OF THE SERVICES REQUIRED

In order to organise and manage the organisation of the stakeholder meeting in Krakow, due to the specific service needed, CODOGNOTTO Polska sp. z o.o. (from here on indicated as "Awarding Organisation") requires support in:

- creation and management of a coordinated image of the event in line with the CE 2014-2020 Programme rules, under the supervision of the partner;
- designing, printing and delivery of event material;
- preparation of the premises;
- accommodation and subsistence costs for participants (associated partners and speakers). Foreseen n. 15;
