3. PROFESSIONAL PROFILES

- it is possible to use internal resources, equipped with appropriate professional requirements and technical capacity;
- the services are not available considering the Professionals registered to the List are due to their technical or qualitative characteristics, or for the degree of specialization and/or organization required;
- the Proposing Organisation deems it useful to increase the competitiveness compared to the registered professionals, through the launch of a specific competitive and open procedure.
